- **Facilities Reserve Charge (FRC) Offsets Interim Directive**

The Multi-party Facilities Reserve Charge (“FRC”) Offsets Interim Directive dated January 31, 2006, this directive incorporated the Board’s policy guidance provided at its November 4, 2005 meeting. As indicated previously, the Department is still evaluating this interim directive and determining the applicable criteria and/or conditions which will allow developers to qualify for (one-time only) FRC offsets against water system infrastructure improvements which are constructed and dedicated to the Department, as part of their proposed developments.
