Dear Food Service Establishments:

We ask your kokua. Please join the Department of Water in supporting conservation efforts by serving water only upon request.

The proper stewardship of Kaua'i's potable water resources is critical in order to both sustain this finite resource and preserve it for present and future generations of those on Kauai. Conservation of fresh water plays an important part in the careful management of this precious resource.

The House of Representatives of the Twenty-second Legislature of the State of Hawai'i, Regular Session of 2003, through House Resolution No. 174 and House Concurrent Resolution 222 (collectively the "House Resolutions"), requested that the water boards of the counties of Hawai'i, Maui and Kaua'i to adopt administrative rules in their respective counties promoting water conservation by requiring restaurants to serve water only upon request.

The Board of Water Supply fully supports the intent of these House Resolutions to promote water conservation efforts by restaurants, and believes that "Water on Request Only" is an appropriate practice for food service establishments, and also raises the public's awareness about the need for and merits of water conservation.

At the November 12, 2003 Monthly Board Meeting, The Board of Water Supply voted to pass a resolution encouraging all food service establishments on Kaua'i to serve water to their customers only upon request. The resolution was adopted by the Board of Water Supply during its meeting on December 10, 2003. A copy of the resolution is enclosed for your review.



WHEREAS, not only does this practice conserve water, it also raises the public's awareness about the need for and merits of water conservation;



BE IT FURTHER RESOLVED that copies of this resolution shall be provided to all food service establishments on the island of Kauai.

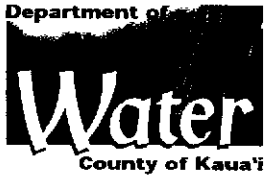

Subject: House Resolution No. 174 and House Concurrent Resolution No. 222


In response to the request for Counties to Promote Water Conservation, as stated in the House Resolution No. 174 and Concurrent Resolution No. 222 which were adopted during the 2003 legislative session, the County of Kauai Board of Water Supply and the Department of Water have adopted Resolution No. 3, encouraging Kauai's restaurants to serve water to their customers only upon request.
