Net Change - Estimate Ending Balance = (\$30,383.00)

Fund Balance Projections (Page 47) – as of June 30, 2021, the Water Utility general fund = \$6.5M. Water Utility (WU) Reserve & WU Debt Reserve – show zero because Reserve Fund Board Policy No. 31 was approved at the May Board meeting which is not consolidated WU Reserve Fund = \$9.3M

DISCUSSION:

Mr. Dill asked why was there a decrease of \$1.6M on the Estimated Available Resources attributed to? Mrs. Yano explained that the estimated change in the fund balance as of July 1, 2020 due to the change in the estimated cash investments receivable and balances of \$50M and encumbrances of \$16M. This was a comparison from the fund balance projections of last month. Encumbrances are \$15.7M and was updated to \$16.5M. Beginning balance \$50.4M; last month was \$50.8M. Current liabilities changed since the last Board meeting at \$4.1M; up \$4.5M this month.

Mr. Calipjo asked how did the current liabilities add up to \$400,000? The current liabilities consisted of the accounts payable, contracts payable, customer overpayments, customer deposits and advances which are equal to \$4M (updated as of May 31, 2020). Net position is broken down with WU Reserves, Restricted FRC (non-spendable projects), BAB funds, Invested in Capital Assets Net of Related Debt includes investment in infrastructure assets, & Unrestricted (billable use for any operating or capital projects by Board approval).

DISCUSSION:

Mr. Kamm asked if the Deferred Outflow of Resources is a liability and fully funded? Mrs. Yano explained that these are payment that the Department paid. It is not recognized as an expense during this fiscal year. It is an asset but deferred which is not a liability.

BACKGROUND:

The Department of Public Works, County of Kaua'i (County) reconstructed the portion of Weke Road that was washed away during the historic flood of April 13-15, 2018. As part of the reconstruction, the County was the lead agency in construction and the scope of the project includes the replacement of the water line for the Department of Water (DOW).

A MOA was executed between the Board and the County on September 28, 2018. In the terms of the MOA, the County would be requesting reimbursement from FEMA, 75% of the cost to complete all of the water facilities work they were doing for the DOW. FEMA allows up to 75% of the cost to be reimbursable by FEMA. The DOW would pay the County the remaining 25% of the cost of the water line work that is not reimbursable by FEMA to the County.

Subsequent to the execution of the original MOA, the Hawai'i Emergency Management Agency (HIEMA) determined that the County's scope of work to FEMA did not include all of the water facilities and that the portion of the work not covered by the County was covered by the DOW's scope of work to FEMA. HIEMA requested that the MOA completed be revised to specify that the County would be requesting reimbursement from FEMA for the portion of the water line work HIEMA determined to be in the County's FEMA scope of work and the DOW would be requesting reimbursement from FEMA for the other portions of the water line work covered in the DOW's scope of work (not covered in the County's scope of work to FEMA).

The County has submitted an invoice to the DOW in June 2020 for the total cost of the work. From the invoice, the DOW calculated that the DOW's obligation to the County based on the current FEMA scope of work is \$96,250.00. There was a construction change order that was not included in the FEMA scope of work in the amount of \$42,965.00. If this change order scope of work is not allowed to be added by FEMA, the DOW should reimburse the County for this full change order amount. If FEMA allows the change order work and reimburses the County 75% of the cost of the change order work, then the DOW should pay the County the remaining 25% of the change order cost. At the time of this report, it is not known if FEMA will accept the change in scope for FEMA reimbursement so the DOW is requesting that the full change order amount be approved in the funding.

OPTIONS:

Option 1: Approve the First Amendment to the Memorandum of Agreement.

Pro: This will meet HIEMA's request that the original MOA be revised and allow the County and the

DOW to request reimbursement from FEMA for the applicable water facilities in the FEMA scope of work and for the DOW to reimburse the County fairly for the work the County completed for

the DOW.

Con: None known.

Option 2: Do not approve First Amendment to the Memorandum of Agreement.

Pro: None known.

Con: Not approving the submittal of Memorandum of Agreement would prevent the MOA from being

revised per HIEMA's request and it may result in loss of the maximum FEMA reimbursements for the water line work. There will also not be an agreement if place to reimburse the County fairly.

AMENDMENT TO MEMORANDUM OF AGREEMENT

FOR

RECONSTRUCTION OF WEKE ROAD AND REINSTALLATION OF DAMAGED WATER MAIN AND APPURTENANCES HANALEI WATER SYSTEM

THIS MEMORANDUM OF AGREEMENT ("Agreement") is made and entered into by and between the COUNTY OF KAUA'I BOARD OF WATER SUPPLY (hereinafter referred to as the "BWS"), whose business and mailing address is 4398 Pua Loke Street, Līhu'e, Hawai'i 96766, and the COUNTY OF KAUA'I (hereinafter referred to as the "COUNTY"), acting through its DEPARTMENT OF PUBLIC WORKS, whose principal place of business and mailing address is 4444 Rice Street, Suite 275, Līhu'e, Hawai'i 96766.

RECITALS

WHEREAS, the historic flood of April 13-15, 2018 damaged the County's Black Pot Beach Park and Weke Road including the water distribution system and its appurtenances along, under, and within Weke Road and the County Right-of-Way; and

WHEREAS, the COUNTY is the owner of that certain parcel of land upon which County road, Weke Road is situated; and

WHEREAS, the BWS is the owner of the water distribution system and appurtenances (herein referred to as "BWS Facilities"); and

WHEREAS, both the COUNTY and BWS will seek funding reimbursement from the Federal Emergency Management Agency (FEMA); and

WHEREAS, the BWS desired the reconstruction of the BWS Facilities which are located within the County Road and the County Right-of-Way; and

WHEREAS, the County and BWS entered into a Memorandum of Agreement to declare that the work to demolish, remove, reinstall, and reconstruct the BWS water distribution system and appurtenances would be included in the RAIN18 projects to reconstruct Weke Road, and to apportion the costs for work done for the reconstruction of Weke Road which work included the demolition, removal, reinstallation and reconstruction of the BWS water distribution system and appurtenances; and

WHEREAS, FEMA and the Hawai'i Emergency Management Agency (HIEMA) requested changes to provisions in the Original Agreement involving the apportionment and reimbursement of project related costs. To wit, the costs for the water line, fittings, and appurtenances to these were determined by HIEMA to be in the COUNTY scope of responsibility with regard to FEMA reimbursement. The costs for the water meters, laterals, fire

hydrant, water valve, and related appurtenances to these were determined by HIEMA to be in the BWS scope of responsibility with regard to FEMA reimbursement, and the COUNTY and the BWS would each submit separate reimbursement requests to FEMA for their portion of costs of the water facilities work in their respective requests to FEMA.

NOW THEREFORE, in consideration of the mutual covenants and promises herein made, the parties do hereby agree as follows:

- This Agreement supersedes the original Memorandum of Agreement for Reconstruction of Weke Road and Reinstallation of Damaged Water Main and Appurtenances, Hanalei Water System that became effective on September 28, 2018.
- The COUNTY shall utilize any and all available BWS record drawings for reconstruction and reinstallation of the BWS Facilities during the design of any road reconstruction of the County Roads.
- 3. The BWS Facilities design shall conform to Water System Standards, 2002, as amended, as reviewed and approved by BWS. Reconstruction and reinstallation of BWS Facilities shall be monitored and inspected by a BWS inspector. The BWS will issue a Final Inspection notice upon satisfactory construction for the BWS water facilities construction work done by COUNTY for the BWS and a Certification of Completion upon completion of the post construction required submittals.
- 4. The COUNTY shall include the removal and proper disposal of the old and damaged BWS Facilities in the bid specifications and contracts relating to the reconstruction of the County Road that contain BWS Facilities.
- 5. The BWS shall pay the COUNTY for the project contractor's costs attributable to the removal and replacement of BWS's water system facilities as follows:
 - a. The BWS shall pay the COUNTY 100% of the project contractor's costs attributable to BWS's twenty (20) water meters, one (1) water valve, one (1) fire hydrant and related appurtenances including lateral pipes, fittings, reaction blocks, meter boxes and other facilities not specified in the original scope of work due to field conditions and as allowed by FEMA.
 - b. The BWS shall pay the COUNTY 25% of the project contractor's costs attributable to the removal and replacement of all other elements of BWS's water system facilities not included in subparagraph 4a and in the COUNTY scope of work to FEMA, and other water facilities as allowed by FEMA.
 - c. The COUNTY shall provide copies of invoices which detail the completion of the reconstruction and reinstallation of the BWS Facilities not later than sixty calendar days of the execution of this First Amended to the Original Agreement.
 - d. BWS shall pay the COUNTY within sixty calendar days of receipt of the invoices from the COUNTY. Costs attributable to the BWS may be adjusted for any reimbursement from FEMA either directly or indirectly.

6. If not otherwise terminated or canceled, this Agreement may be canceled by the mutual written agreement of the parties hereto. This Agreement shall automatically terminate upon issuance of the Certificate of Completion for the BWS Facilities and final payment to COUNTY by the BWS.

BACKGROUND:

As requested by the Board of Water during its January 24th and February 28th Regular Board meeting, the Board requested the Department to provide a monthly update on the status of payments to Grove Farm in accordance with the project's budget. Please refer to Attachment 1.

There is one item to highlight on Attachment 1, shown as "Taxes and Additional US Customs Duty Fees, in accordance with SUEZ's proposal dated 9/16/2019" under the "Membrane Unit Replacement" category. Due to a misunderstanding between the membrane manufacturer, Suez, and Grove Farm it was previously thought that these taxes and fees were included in the lump sum total for the \$1,015,545.00 line item listed as "Membrane Unit Upgrades by Suez, all in accordance with SUEZ's proposal dated 9/6/2019". However, State tax (4.166%) and County of Kaua'i tax (0.546%) should have been added to this line item. The total amount of taxes and fees is therefore \$47,852.48 and the DOW's 2/3 cost-share of this item, per the Water Treatment and Delivery Agreement, is \$31,901.65.

DOW staff initially rejected the invoice from Grove Farm requesting the \$31,901.65 in taxes and fees as this line item was shown as \$0 in the cost estimate table that was agreed upon by the DOW and Grove Farm and approved by the Board at the February 28, 2020 Board meeting. However, after further discussions with the Board Chair, DOW staff were authorized to approve the invoice on the basis that:

- 1. The request is fair and reasonable, and
- 2. It is understood and acknowledged by DOW staff and the Board that the actual construction costs may differ from the line item estimates approved by the Board at the February 28, 2020 Board meeting. DOW staff are authorized to exercise judgment in approving invoices as long as the Board-approved project total of \$2,821,347.00 is not exceeded. In the future, should an invoice request an amount that would exceed this project total, the DOW will evaluate the request and, if deemed fair and reasonable, bring the request to the Board for approval of any additional funds.

For transparency, DOW staff approved the invoice for the \$31,901.65 in taxes and fees, and DOW staff will continue to review and approve invoices based on this direction from the Board Chair unless

instructed otherwise. Any discussion or direction from the Board at the July 23, 2020 meeting is welcome.

Construction Update:

As requested by the Board at the June 25, 2020 Board meeting, DOW Engineering staff visited the Waiahi Surface Water Treatment Plant to inspect the new membrane installation and verify the items shown on invoices requested to date. There were no issues noted and all invoices have been paid within 15 calendar days.

Update from Grove Farm:

As requested by the Board at the June 25, 2020 Board meeting, Grove Farm has provided an update regarding the performance of the new membranes; please see Attachment 2.

ATTACHMENT 2

Waiahi Water Company

The original *Water Treatment and Delivery Agreement* was entered into by Grove Farm Properties, Inc. and the Board of Water Supply in February 2004. Grove Farm's obligation under this agreement was to design, construct, finance and operate the facility to deliver to the Kauai Department of Water with safe drinking water.

Waiahi Surface Water Treatment Plant – Membrane Refurbishment Background

The Waiahi Surface Water Treatment Plant (SWTP) was commissioned in late 2005 with a rated capacity of 3.0 MGD. The SWTP utilizes an immersed membrane filtration process called ultrafiltration (UF). UF is typically used to separate or remove particles, such as microbes, bacteria, and macromolecules.

The SWTP has four processing tanks, called trains, and each train holds two cassettes. The original cassettes were populated with 52 modules each. Each module is made up of about 2,700 fibers. These fibers are the filters that produce high quality permeate by drawing the raw water through an 'outside-in,' vacuum process.

In June of 2020, the original membranes were replaced after 15 years of service. The plant has been a reliable source of drinking water since its inception. The manufacturer recommended a replacement schedule of +/- 10 years, pending on the condition of the membrane over time. The Waiahi SWTP filters performed for 5 years beyond their expected useful life. Imminent replacement was called for as the aged cassette hardware resulted in a reduction in processing capacity. Over time, the fibers experienced shrinkage. Every three to five years, the operators worked with a technician to conduct slack adjustments on the fibers, with the goal of optimizing for production. With time and because the membranes far exceeded their projected useful life, there was no room for any further slack adjustments. We risked compromising the membranes and losing this critical source of potable water for the DOW.

Over the years of operation, ten modules were completely removed from production. Water quality was never compromised as the remaining fibers, the core to the filtration process, continued to produce high quality water. Daily membrane integrity tests and pressure checks allowed operators to plug fractured fibers. It was the aging on the hardware, headers/footers or potting molds cracks that required module removal. The installation of the new membranes and updated software brings more efficiency to the process and regulatory compliance monitoring.

The filter fiber technology has not altered much, however, the manufacturer has made several improvements to its Zeeweed 500d model design over the last 15 years. One being the increase in fiber square footage per module and more sturdy hardware. Thus, the recent installation has each cassette populated with 42 modules (versus 52) with the rated production capacity of 3.0 MGD.

In summary, the plant has always delivered safe drinking water to the DOW. With this project being completed, the efficiency of the plant is now much improved. We are no longer in a compromised position by using the old membranes 50% longer than the projected useful live. Given this fact and the critical nature of this source of potable water for more than 20% of the DOW customers, those were the two primary factors driving the "urgency" in replacing the membranes.









Re: Discussion and Possible Action to Request Board Approval for Indemnification for CrowdStrike Falcon Complete software between the Board of Water Supply, County of Kaua'i and CrowdStrike

RECOMMENDATION:

The Department recommends that the Board approve Option 1, which will allow the Department to move forward with the purchase and implementation of a new Endpoint Protection software.

FUNDING: N/A

BACKGROUND:

Currently, the Department's Information Technology Division (IT) is utilizing Symantec Endpoint software to manage its internet security. The software provides intrusion prevention, firewall, and anti-malware features; and, is installed on all of the Department's servers, office workstations and remote laptops.

In light of the evolving internet and network requirements of the Department, with the proposed improvements identified and in the process of implementation, of the IT Strategic Plan, coupled with the added deployment of remote laptops for teleworking employees, due to COVID-19, the IT Division has reviewed and reassessed its internet security capabilities. The Symantec Endpoint software is capable of providing the security needs of the Department. However, it requires continual IT staff resources and technical support to monitor and maintain the system to manage the Department's internet security.

The Department's IT staff have reached out to technical experts in the internet security field, as well as, the County of Kaua'i's IT Manager, to review and discuss solutions which would provide the internet security necessary with added efficiency – reduction in IT staff resources. Based on those recommendations and the fact that the County of Kaua'i's IT Division has recently reviewed and has implemented new internet security software by CrowdStrike, Inc., the IT Division proposes to utilize and implement the Crowdstrike, Inc. internet security software along with its technical support.

The internet security software and its associated technical support by CrowdStrike, Inc. provides similar features as the Symantec Endpoint software along with added features, internet security monitoring, quarantining, removal and repair of system files to provide added protection for the Department's internet system. Additionally, it will be able to provide the proper number of licenses to allow the Department to protect all of its current as well as near future equipment needs.

The Department's IT staff has been working closely with our Deputy County Attorney to review and approve of the Terms and Conditions from CrowdStrike, Inc. However, before the IT Division can move forward with the software implementation Board approval is required as the agreement contains language for unspecified future obligations such as indemnification and governing law provisions.

The sections within the agreement that reference Indemnification, Limitation of Liability, and Governing Law and Arbitration are shown below:

CROWDSTRIKE TERMS AND CONDITIONS:

9. Indemnification.

9.1 <u>CrowdStrike's Obligation</u>. CrowdStrike shall at its cost and expense: (i) defend and/or settle any claim brought against Customer by an unaffiliated third party alleging that an Offering infringes or violates that third party's intellectual property rights, and (ii) pay and indemnify any settlement of such claim or any damages awarded to such third party by a court of competent jurisdiction as a result of such claim; provided, that Customer: (a) gives CrowdStrike prompt written notice of such claim; (b) permits CrowdStrike to solely control and direct the defense or settlement of such claim (however, CrowdStrike will not settle any claim in a manner that requires Customer to admit liability without Customer's prior written consent); and (c) provides CrowdStrike all reasonable assistance in connection with the defense or settlement of such claim, at CrowdStrike's cost and expense. In addition, Customer may, at Customer's own expense, participate in defense of any claim.

10. Limitation of Liability.

10.1 TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, EXCEPT FOR LIABILITY FOR ANY AMOUNTS PAID OR PAYABLE TO THIRD PARTIES UNDER SECTION 9 (INDEMNIFICATION), CUSTOMER'S PAYMENT OBLIGATIONS, AND/OR ANY INFRINGEMENT OR MISAPPROPRIATION BY ONE PARTY OF THE OTHER PARTY'S INTELLECTUAL PROPERTY RIGHTS. NEITHER PARTY SHALL BE LIABLE TO THE OTHER PARTY IN CONNECTION WITH THIS AGREEMENT OR THE SUBJECT MATTER HEREOF (UNDER ANY THEORY OF LIABILITY, WHETHER IN CONTRACT, STATUTE, TORT OR OTHERWISE) FOR ANY LOST PROFITS, REVENUE, OR SAVINGS, LOST BUSINESS OPPORTUNITIES, LOST DATA, OR SPECIAL, INCIDENTAL, CONSEQUENTIAL. OR PUNITIVE DAMAGES. EVEN IF SUCH PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR LOSSES OR SUCH DAMAGES OR LOSSES WERE REASONABLY FORESEEABLE; OR (B) AN AMOUNT THAT EXCEEDS THE TOTAL FEES PAID OR PAYABLE TO CROWDSTRIKE FOR THE RELEVANT OFFERING DURING THAT OFFERING'S SUBSCRIPTION/ORDER TERM. THESE LIMITATIONS WILL APPLY NOTWITHSTANDING ANY FAILURE OF ESSENTIAL PURPOSE OF ANY REMEDY SPECIFIED IN THIS AGREEMENT. MULTIPLE CLAIMS SHALL NOT EXPAND THE LIMITATIONS SPECIFIED IN THIS SECTION 10.

14.3 <u>Governing Law; Venue</u>. Except as otherwise provided in Exhibit B (if applicable), this Agreement, and the rights and duties of the parties arising from this Agreement, shall be governed

by, construed, and enforced in accordance with the laws of the State of California, excluding its conflicts-of-law principles. The sole and exclusive jurisdiction and venue for actions arising under this Agreement shall be state and federal courts in Santa Clara County, California, and the parties agree to service of process in accordance with the rules of such courts. The Uniform Computer Information Transactions Act and the United Nations Convention on the International Sale of Goods shall not apply. Notwithstanding the foregoing, each party reserves the right to file a suit or action in any court of competent jurisdiction as such party deems necessary to protect its intellectual property rights and, in CrowdStrike's case, to recoup any payments due.

Public Relations Program

Community Outreach & Education

- Public Relations staff (PR) has been progressive in the improvement and increase of direct communications with customers; by providing courtesy calls, assisting divisions with information dissemination and by issuing additional notices regarding service disruptions, service inquiries, etc. *On-going*.
- PR continues to assist public notification of the Department of Health's Customer Confidence Reports (CCR), also known as Water Quality Reports. On June 23, 2020 an update was made to the reporting method of the water quality report and the published reports were updated. A second round of notifications were sent; including a mail-out of the revised reports were completed, with the revised reports.
- To promote water emergency preparedness in our community during hurricane season, PR is preparing radio advertisements, social media posts and a water jug distribution event to distribute collapsible jugs in 4 locations around the island. The water storage jug features step-by-step instructions on how to safely store water in preparation of an emergency or when water service may be temporarily unavailable. PR is partnering with the Department of Education to help distribute the jugs during their free meal programs at Waimea High School, Koloa Elementary, Chiefess Kamakahelei Middle School and Kapa'a High School. This is the first community outreach event since the Department suspended its community outreach events in March. PR will conduct post-event evaluations to help determine the planning of future outreach events.

Advertising

• PR has increased social media efforts to promote the Department's available services, water emergency preparedness tips and continue water conservation program efforts through hurricane season and office closure due to COVID-19. An estimated 12,700 people viewed the Department's Facebook page posts over a 25-day period in June 2020; which included the promotion of billing services, office contact information, conservation and emergency and planned service shutdowns. The page also received 30 new page followers in the month of June. We anticipate a continued increase of customer service and community interaction on the Department's Facebook page as the Department moves to online services. PR will continue

- to adjust and adapt resources towards providing effective communications and online customer services via social media tools to support this effort.
- PR continues to support the Department with COVID-19 related updates and planning efforts as needed; including news releases, customer notifications, updated service announcements, etc. PR will be reviewing additional print advertisement opportunities in the new fiscal year to expand the Department's educational and service awareness outreach efforts.
- PR has secured radio advertising contract renewals with Pacific Media Group, Inc. and FM97 radio stations for the Fiscal year 2020-2021. Pacific Media Group (formally known as Kong Radio Group) is Kauai's civil defense radio station with a very wide outreach that the Department would like to extend its messages to. The Department's target audience fits the demographics of FM97's adults' age 25-54 listening at home and at work. PR discussed the Department's need for consistent radio advertising to notify public of water system-related announcements (i.e. water shutdowns, road closures, emergency service announcements, outages, workshops, festivals and general water information). Both radio stations agreed to the Department's need for flexibility on airing announcements and offered the Department a primetime spot when ads are scheduled. PR conducted competitive research for radio advertisement and a third proposal was also received from H.Hawaii Media radio station, however, it was not favorable in consideration of budget and target reach when compared to the other stations.



QUARTERLY *UPDATES* – 2nd **Quarter** (April – June 2020)

WATER QUALITY QUARTERLY REPORT:

- 1. Engineering continues to work with the Lab and contractors to install sample stations in new subdivisions. The new subdivision behind the Poipu Shopping Center will also have a sampling station. They will be added to the updated sampling plan required by new Total Coliform Rule. One has been installed in the current Hanamaulu project. One more slated for the expansion of the Ulu Ko subdivision. The Lab will incorporate the Hanamaulu Station and Poipu Subdivision station into the Routine Sampling Plan in 2019. Sampling Points are being looked at to update the site list before end of year when the Compliance Monitoring Data Portal (CMDP) is implemented. So, the next sample station may in the new Kulana Subdivision after it is conveyed to DOW.
- 2. Micro data is being submitted to CMDP website. Hawaii is still in the test environment, however, SDWB is saying we are going real time shortly. Covid19 has slowed thing down.
- 3. Continued microbiological sampling of sources to see if any will present problems with fecal indicators. This is part of the Triggered Monitoring part of the Ground Water Rule.
- 4. Phase 2-5 sampling for 2017-2019 period completed. Sampling for the 2020-2021 period will begin later this year. System 400 is scheduled for 3rd and 4th Quarter 2020
- 5. Baseline Chemistry for sources ongoing. Emphasis is on pH at problem sources, Puhi #3 and Wainiha #2. The existing soda ash equipment at Waihiha #2 initially boosted the pH to 7.0. We are monitoring it monthly with the addition of alkalinity testing and it seem to be holding. Testing results are sent to SDWB for their records. SDWB has put the system on an advanced monitoring schedule for Lead and Copper (20 samples 2x/year). This is problematic as it is difficult to get volunteers out there because mostly, it is vacation rentals. However, both rounds were accomplished with results below the Action Level so Sys.415 only has to sample once in 2019 which was completed this Qtr. Sampling will also occur in July of 2020.
- 6. Contract for analytical services with Eurofins has been extended to FY 2020-2021. Contract executed. RTM has been submitted for FY2020 budget. RTM was not submitted for 2021 as contact covers 2021 fiscal year.
- 7. Updated sample site plan and sites on Xcel spreadsheet. Continuing.
- 8. Lab inspection for microbial analysis certification in April 2018 passed. Next inspection is in 2020 but not sure due to COVID19.
- 9. Microbiological analysis ongoing with no coliform hits.
- 10. Maintenance and filter replacement completed for RO system. Although we may have to do water suitability testing anyway. Connected autoclave to RO system to use more water. It seems to be working as we are getting conductivity readings below 1.0 uU/cm. Still good.
- 11. UCMR 4 Updating SDWARS inventory and scheduling. Sys. 400 AM1, AM2 and AM3 UCMR4 is completed for 2019. Next round will be in May 2020.
- 12. PCBs found in Paua Valley tank. Tank has been isolated. Lab is working with SDWB and Engineering to get tank back on line. Ongoing.
 - a. On Kauai entry points to distribution (EPD) are usually after the well head and before the storage tanks. The reason for this is because well water can go into the distribution system before going to a storage tank. This is common to most of DOW sources.
 - b. Therefore, chemical (and to a limited extent, microbiological) samples are taken at the EPDs before going to the storage tanks. DOH does not require sampling from the tanks unless it represents an EPD. There are two tanks that qualify, the Kalaheo Deep Well Tank and the Anahola Tanks.
 - c. Because of the recent findings, we are requesting sampling taps on the storage tanks (many do not have them). OPS has installed taps on most of the tanks in question. They have been sampled for PCB.
- 13. We are back on schedule for sampling and testing with the DOH Lab.

- 14. Microbiological QA/QC items for certification completed for 2nd Qtr. 2020.
- 15. Monitoring of chlorides in Sys. 406 ongoing. Waipa Well back in service.
- 16. All Lab personnel are working in Lab. Peggy and Carl are on the 4-10 work week and Andy is on the 5-8 work week.
- 17. Working with Brown and Caldwell on GAC system in Wailua Homesteads. We will be doing the required sampling and paying for the testing.
- 18. Will be looking at the Moalepe Tunnel chlorination project again to revive it.



Executive Summary

The significant changes for this quarter are:

- Representing KDOW in Teleconference with neighbor island Managers for statewide coordination efforts and reporting. Recent topics include sharing of information and processes regarding the COVID-19 situation and also DOH participation in reaching out to Managers.
- WRP division staff Michael Hinazumi agreed to volunteer and step up in the interim period and be the Point Person for IT division.


