BACKGROUND:

Waterworks Controller Mrs. Marites Yano referenced the Billed Revenues Comparative Chart, Page 122. The accumulative billed revenues is \$682,862. Cash Receipts was down by \$3M and Mrs. Yano explained that at the same time last year, the Department received a \$2.2M State grant that resulted in a decrease in cash receipts. Metered Consumption, Page 124 – is the decrease for the month, 66M gallons YTD. YTD Metered Consumption, Page 125 showed a cumulative decrease of 97M gallons. Monthly Budget Summary vs. Actual, Page 114 – Water sales is up by \$875,371 YTD due to conservative revenue projections.

Collection efforts with island utilities during the pandemic – Fiscal reached out to Board of Water Supply, County of Maui, County of Hawai'i and Honolulu Board of Water Supply who are suspending all collection efforts until December 31, 2020. The Department of Water will also suspend collections until the end of the year.

DISCUSSION:

DOW does not need a policy to suspend collections until December 31st because this is only temporary according to Mrs. Yano. The collection efforts are already in the Rules & Regulations.

BACKGROUND:

Information & Education Specialist Mrs. Jonell Kaohelaulii provide the following highlights:

- 1. PR continues to support customer service efforts during the COVID related closures through social media, revised internal procedures for public notices and Black Board Connect. PR supports all divisions with customer relations and public service announcements.
- 2. Increasing education and community outreach efforts Next community outreach is Water Education Today (WET) is the kit distribution event for keiki on Tuesday, October 6th 9 am to 10 am at the Vidinha Stadium parking lot. This is a drive through event and open to the public. Volunteers are needed especially the Board to assist in distributing 700 water education kits to the public. This is part of the Department's Imagine a Day without Water campaign held in October.
- 3. PR is developing a Facebook campaign for the Department and joining thousands of water agencies across the nation to educate local communities about the value of water. PR is co-leading the state-wide effort with the sister water departments to host Facebook campaigns.
- 4. PR is hosting a hashtag value water challenge on Facebook to encourage the community the question: Why is water important to you? Water and water infrastructure to provide water service should not be taken for granted. Community member interviews will be scheduled to share their water story on this campaign.
- 5. Project WET Hawai'i on line Trainings County and State agencies will be continuing training on line.

Dear Mr. Akamine, Chairman, and Fellow Board Members

As you are aware, COVID 19 has wreaked economic and personal hardship on everyone. No one would have predicted the nature and extent of the losses. The retail sector has been hit particularly hard and the tenants and owner of Kauai Village are experiencing the same adversities as everyone else. Unfortunately, some tenants have been forced to close, while others seek assistance for any support source possible including from ownership. Ownership also has financial and lease obligations and is struggling to adapt and survive. However, we are committed to working closely with our tenants doing our part to support them in this critical time of need.

We are also fully committed to the Kauai community and to this investment. We recently completed façade renovations and repairs to the parking lots. These capital investments were in excess of \$X.XX and resulted in an improved overall look and experience for our customers. We are very fortunate to have signed new tenants including Hawaii Pacific Health which recently opened a medical clinic to serve the residents of East Kauai. Other recently signed tenants remain committed to opening their businesses. However, these tenants seeking building permits have been informed by DOW that no permits will be issued until the Village installs a back flow preventor for the fire suppression line.

Kauai Village was constructed in 1989. It was built in accordance with the approved plans and then applicable codes. The Village consists of a 6" domestic water line, providing water service to the tenants. Additionally, there is an isolated 8" fire protection water line, with a total of five risers, each constructed with a check valve assembly and an 8" Detector Check Valve and Meter. This is an effectively "closed system." Lastly, there is an irrigation water line. Both the 6" domestic water line and the 2" irrigation water line have their own reduced pressure back flow preventors. We have attached copies of the approved plan sheets supporting the above information.

We understand the recent objective to gain compliance with the code amendment. We also understand that certain property owners may not be compliant. However, given the information above, are asking for your consideration and some timing flexibility with this unexpected and expensive retrofit of the fire suppression water system. As a result, we propose the following:

Kauai Village shall immediately undertake and complete the design drawings for a back flow preventor of the fire suppression line and will submit the plans from a Hawaii Mechanical Engineer within 90 days of approval of our request. We ask for a three-year period from time of plan approval to construct and install the back flow preventor. This will provide ownership with time to get through the worst of the economic crisis, support our tenants, invest into tenant improvements, prepare bid documents, select a contractor, and perform the work.

We appreciate your consideration of our request and hope that we can reach an equitable resolution. The above proposal demonstrates our commitment to comply with the requirement and affords us the time needed to steer through this difficult period. Please don't hesitate to contact me should you wish to discuss further.



BACKGROUND:

As a result of the historic flood of April 13-15, 2018, the Department of Public Works, County of Kaua'i (County) needed to reconstruct the portion of Kahiliholo Road that was washed away. The washed out section of the roadway left the Department of Water's (DOW) water line exposed and unsupported. The County and the DOW decided that it would be advantageous for the County to repair the water line for the DOW with the County's road repair work. By comparison, the road would need to be repaired before the permanent water line could be repaired and replaced. Therefore, including the water line in the County's scope of work for the road repairs would allow for the permanent water line to be completed significantly sooner.

The County included the repair of the water line in their contract's scope of work for the road repairs. The understanding between the DOW and the County was that the DOW would reimburse the County for the

water line repair work done by the County, as it was in the best interest of the public to include the water main repairs with the road repairs.

A MOA between the County and the DOW was executed on April 26, 2019. In the terms of the MOA, the County would be requesting reimbursement (75% of the cost) from FEMA for the water line work completed by the County and the DOW would reimburse the County the remaining 25% or, amount not reimbursed to the County by FEMA.

Subsequent to the execution of the original MOA, the Hawai'i Emergency Management Agency (HIEMA) determined that although the County included the water line work in their scope of work for their contractor, the County's scope of work to FEMA did not include the water line work. HIEMA requested that the MOA completed be revised to specify that the DOW would be requesting reimbursement from FEMA for all of the water line work and the County shouldn't as it is not in the County's FEMA scope of work. HIEMA requested that the DOW submit a request to FEMA to consider that all of the water line work be considered for reimbursement. This was done. FEMA has not responded to our request yet so we do not know if we will be able to be reimbursed. In either case, the DOW will need to reimburse the County 100% of the cost of the water line work in good faith. The amended MOA would allow the DOW to reimburse the County.

Therefore, the Department is recommending that the Board approve the First Amendment to the MOA and the estimated funds to reimburse the County. The actual amount of the reimbursement will be known after the County submits the required invoices to the DOW.

OPTIONS:

Option 1: Approve the First Amendment to the Memorandum of Agreement and expenditure

of \$44,100.00 in funds.

Pros: This will allow the Department of Water to reimburse the Department of Public Works

(DPW), County of Kaua'i for 100% of the repairs for the affected water facilities due to the historic flood of April 13-15, 2018. Allowing DPW to be the lead agency for this work has

saved the DOW time, manpower, resources, and money.

Cons: None.

Option 2: Do not Approve the First Amendment to the Memorandum of Agreement and

expenditure of \$44,100.00 in funds.

Pros: None.

Cons: The DOW will not be able to reimburse the County for the emergency water line repair

work the County completed for the DOW.

Not providing 100% of the total funding for the water line repair work could jeopardize the working relationship and corrode trust between the County and the DOW going forward. This could include any future emergency work which requires coordination between the County and DOW. In turn, this would be detrimental to the services we provide

to the people of Kaua'i.

MEMORANDUM OF AGREEMENT

FOR

KAHILIHOLO ROAD AND CULVERT REPAIRS KĪLAUEA-KALIHIWAI WATER SYSTEM

RECITALS

WHEREAS, the historic flood of April 13-15, 2018 damaged the County of Kaua`i's Kahiliholo Road including the water distribution system and its appurtenances along, under, and within Kahiliholo Road; and

WHEREAS, the COUNTY is the owner of that certain parcel of land upon which Kahiliholo Road is situated, including the County Right-of-Way; and

WHEREAS, the BWS is the owner of the water distribution system and appurtenances (herein referred to as "BWS Facilities"); and

WHEREAS, both the COUNTY, acting through its DPW, and BWS will seek funding reimbursement from the Federal Emergency Management Agency ("FEMA") for costs related to the damage to Kahiliholo Road; and

WHEREAS, the BWS desires to remove, repair, reconstruct and reinstall the BWS Facilities which are located within the Kahiliholo Road and the County Right-of-Way; and

WHEREAS, the COUNTY is willing to include the removal, repair, reconstruction, and reinstallation of the BWS Facilities in the Kahiliholo Road and Culvert Repair - Rain18 Project (the "Project"), provided that the BWS and the COUNTY, acting through the DPW, enter into the Original Agreement for the removal, repair, reconstruction, and reinstallation of the BWS Facilities; and

WHEREAS, the COUNTY will enter into a contract for the removal, repair, reconstruction, and reinstallation of the BWS Facilities as a portion of the overall Project; and



WHEREAS, FEMA and the Hawai'i Emergency Management Agency (HIEMA) have requested changes to provisions in the original MOA involving reimbursement of Project related costs; and

WHEREAS, the COUNTY included the removal, repair, reconstruction, and reinstallation of the BWS Facilities in the COUNTY's contract for the Project, which was submitted to FEMA.

WHEREAS, HI-EMA has determined that the BWS will need to request reimbursement from FEMA for the cost to remove, repair, reconstruct, and reinstall the BWS Facilities to be done under the COUNTY's contract for the Project, and that reimbursement from FEMA is anticipated to be 75% of the cost to remove, repair, reconstruct, and reinstall the BWS Facilities.

WHEREAS, The COUNTY shall not request reimbursement from FEMA for the cost to remove, repair, reconstruct, and reinstall the BWS Facilities as part of the COUNTY's Kahiliholo Road Project.

NOW THEREFORE, in consideration of the mutual covenants and promises herein made, the parties do hereby agree as follows:

- 1. This Agreement supersedes the original Memorandum of Agreement for Kahiliholo Road and Culvert Repairs Kīlauea-Kalihiwai Water System that became effective on April 26, 2019.
- 2. The DPW shall utilize any and all BWS record drawings for the BWS Facilities available during the design of any road reconstruction of the County Roads. Specifically, DPW's Kahiliholo Road and Culvert Repair, Rain18 Project records.
- 3. The design of the BWS Facilities shall conform to Water System Standards, 2002, as amended, as reviewed and approved by BWS. The removal, repair, reconstruction, and reinstallation of the BWS Facilities shall be monitored and inspected by a BWS inspector. The BWS will issue a Final Inspection notice upon satisfactory completion of the removal, repair, reconstruction, and reinstallation of the BWS Facilities under the COUNTY's contract for the Project, and a Certification of Completion upon completion of the required post-construction submittals.
- 4. The COUNTY bid specifications and contract shall include:
 - a. The removal and proper disposal of the temporary water line and old/damaged BWS Facilities.
 - b. The repair, reconstruction, and reinstallation of the BWS Facilities.
- 5. The DPW shall provide copies of Project invoices which detail the completion of the removal, repair, reconstruction, and reinstallation of the BWS Facilities in a timely manner to allow the BWS adequate time to submit a request for reimbursement from FEMA.



- 6. The BWS shall pay the COUNTY for all of the Project costs attributable to the removal, repair, reconstruction, and reinstallation of the BWS Facilities within 60 days of receipt of the invoices outlined in item 5 above, or from the date of execution of this agreement, whichever is the later date.
- 7. This Agreement may be canceled by the mutual written agreement of the parties. This Agreement shall automatically terminate upon issuance of the Certificate of Completion for the BWS Facilities by the BWS except items 5 and 6 above which shall survive the termination of this Agreement.

BACKGROUND:

Contract NTP Date: July 10, 2017
Original Contract End Date: March 16, 2018

The DOW started Job No. 17-10, WP2020 Project No. KW-07 Rehabilitate Paua Valley Tank #1, 0.5MG Concrete to address the aging tank located in Kekaha and to perform repairs,

including fixing a leak located at the base of the tank. As part of the project, DOW performed hazardous material surveys to ensure proper disposal of any material intended to be removed. The presence of polychlorinated biphenyls (PCBs) within the interior of the tank was not expected, based on DOW prior tests for PCBs of the tank water. However, results of the hazardous material survey identified the presence of polychlorinated biphenyls (PCBs) within the interior liner of the tank (testing for PCBs on exterior of tank was not required), which required the shutdown of the tank and the involvement of the Department of Health (DOH) Hazard Evaluation and Emergency Response Office (HEER) and the Environmental Protection Agency (EPA) to provide direction of proper removal and disposal of the PCBs. Design mitigation of PCBs if detected was not included in the scope of work.

First Amendment (executed May 15, 2018)

After discussions with HEER and EPA, specifications needed to be provided for proper removal and disposal of the interior liner of the tank. Additionally, the soils in the drainage ditch needed to be tested for the presences of PCBs, as this is where the tank discharges overflow or washout water.

Second Amendment (executed September 11, 2019):

Testing from the drainage ditch resulted in the presence of PCBs within the soils. Requirements from EPA require that a PCB soil removal plan must be developed and approved by the EPA and HEER for proper mitigation of the soil in the ditch. Therefore, the second contract amendment was necessary to complete the PCB soil removal plan to satisfy requirements from HEER and EPA. EPA clarified that construction of the tank rehabilitation was not dependent on the soil removal plan and mitigation of the soil in the ditch and could proceed independently from the soil mitigation of the ditch. The DOW decided to proceed with the construction of the tank rehabilitation.

Third Amendment (executed June 8, 2020):

During the initial stages of construction, the Construction Contractor submitted an RFI requesting that the exterior paint be tested for PCB contamination on the basis that two other DOW tanks have recently tested positive for PCBs in the exterior paint. PCB sampling in the exterior paint is not typically required by the Department of Health or EPA, but the DOW voluntarily chose to sample the exterior coatings of the Pa'anau Tank No. 1 and Kaua'i Inn Tanks as part of Job No. 18-02, the Island-Wide Tank Rehabilitation of Tanks Project. The positive results from those two tanks led the Construction Contractor to request that the Paua Valley Tank project be tested on the basis that they were built during the same timeframe and may have used similar materials.

DOW staff met with EPA Region IX to request a determination as to whether PCB testing of the exterior paint was required. The EPA representative stated that PCB testing is not a standalone requirement; however, it was clarified by EPA that based on case law in California, the EPA can now "reasonably require" the DOW to test the exterior paint for PCBs at the Paua Valley tank because two other tanks in the DOW system tested positive. Therefore, the DOW proceeded with testing the tank's exterior paint for PCBs. Should the results indicate that PCBs are present, additional mitigation will be needed for the removal and disposal of the paint and the Construction Contractor will submit a change order for the project.

Fourth Amendment (proposed):

The PCB sampling results for the exterior paint and roof coating on the Paua Valley Tank (Reservoir No. 1) were positive for PCB. As a result of this, EPA is requiring testing of the soil

and asphalt paving surrounding the reservoir. Additional environmental and engineering work are required to comply with EPA and DOH requirements. Depending on the test results further testing and mitigation may be required. We have reviewed the proposal from KAI Hawaii, Inc. for additional services required and find it acceptable.

Summary of Design:

- **July 10, 2017** Original contract NTP Consultant completed hazardous material testing required in the contract scope of work. Consultant test results report in December 2017 included detection of PCBs in the interior lining of the tank. DOW did not expect this. (note: testing of the tank exterior for PCBs was not required by DOH or EPA at that time and not included in the design scope of work)
- May 15, 2018 1st Amendment to contract executed. Amendment is to address EPA requirement for DOW to mitigate/dispose of interior tank lining and to test soil in drainage ditch (off-site from tank site) for PCBs.
- **September 11, 2019** 2nd Amendment to contract executed. Amendment is to address PCBs being detected in the soil samples from the drainage ditch and subsequent EPA and DOH HEER requirements to address the PCB detected in the ditch soil. EPA clarified that construction of the Paua Tank can proceed, as it is not contingent on the mitigation of the PCB detected in the drainage ditch soil. DOW decided to proceed with construction and a construction contract was executed.
- **June 8, 2020** 3rd Amendment to contract executed. Amendment is to address Construction Contractor's request to test exterior of tank for PCBs and subsequent EPA determination that the testing of the tank exterior needed to be done. This Amendment is for the consultant to complete the additional testing required by EPA.
- October 22, 2020 Proposed 4th Amendment to contract. Amendment is to address PCBs being detected in the exterior paint and roofing material of the tank and subsequent EPA requirement to test the asphalt paving and soil surrounding the tank for PCBs.

OPTIONS:

Option 1: Approve \$212,719.00 in additional funds for the subject contract.

Pro: This will allow DOW to adhere to requirements from HEER and EPA to

develop an approved plan and test for PCB contaminated ashphalt/soils

around the Paua Valley 0.5 MG tank.

Con: Additional funds will be expended.

Option 2: Do not approve \$212,719.00 in additional funds for the subject contract.

Pro: Additional funds will not be expended.

Con: The DOW will not be able to adhere to the requirements from HEER and EPA

to develop an approved plan and test for PCB contaminated asphalt/soils

around the tank site. The project cannot be completed.

LIHU'E — Washing hands with soap and running water is one of the controls in the spread of the novel coronavirus.

How would this be done in "Imagine a Day Without Water?"

• Operations personnel attended Fork Lift certification classes and Driver Safety Classes with the Department of Human Resources.

Source and Storage

- Maintenance workers continued cleaning various remote facilities island-wide. Works
 included clearing of vegetation and drainage as well as repair and construction of
 structures and facilities including access driveways.
- Water Plant Operators performed routine inspection and maintenance at all sites including valve maintenance, piping repair and replacement, chlorination equipment maintenance, and mixing of sodium hypochlorite.
- Department of Health, Safe Drinking Water Branch conducted sanitary survey of Puhi to Kapaa Water System.
- Job-20-05 Waimea Well B Repair awarded to low bidder and award was posted.
- Contract No. 699 for Kapilimao On-Site Sodium Hypochlorite Generation was executed and Notice To Proceed issued.
- Monitoring of Sodium Hypochlorite on-site generation equipment on Makaleha Wells and Tank Site is on-going.
- Electrical workers performed routine electrical maintenance at all sites including SCADA radio troubleshooting, electrical wiring for motor controls, lighting repair and replacement.
- SCADA Contract No. 701 with Glenmount Global Services is being processed.
- Auto mechanics performed routine maintenance of all DOW vehicle and equipment including light, medium and heavy vehicles as well as construction equipment and generators.

Distribution

- Operations Division Field Section crews continue to perform routine leak repair of service laterals and mainlines. Field Section personnel responded to forty four (44) leak repair work orders.
- Field Section personnel installed a service lateral.
- We received a total of 136 calls from customers reporting leaks on the mainline, service laterals, meters, meter boxes and fire hydrants including complaints of no water, complaints of low pressure, high pressure, calls requesting remote site/facility grounds and vegetation maintenance, calls for assistance in shutting off the water meter, calls reporting damaged meter box and cover, reports of leaking or damaged fire hydrants and report of white milky water, and non-water emergency calls mainly customer inquiries. Work orders were generated and all calls resolved. Leak after the meter needs to be addressed by the customer.
- Three service laterals were installed along with five new water meters.
- Operations Division received two (2) emergency calls for hydrants hit by vehicle.
- Relative to the Board's request regarding where we stand on the water audit compared
 with industry standard, we checked with Hawaii Commission on Water Resource
 Management (CWRM) and were provided the following key performance indicator



The DOW started Job No. 17-10, WP2020 Project No. KW-07 Rehabilitate Paua Valley Tank #1, 0.5MG Concrete to address the aging tank located in Kekaha and to perform repairs, including fixing a leak located at the base of the tank. As part of the project, DOW performed hazardous material surveys to ensure proper disposal of any material intended to be removed. Results of the hazardous material survey identified the presence of polychlorinated biphenyls (PCBs) within the interior liner of the tank, which required the shutdown of the tank and the involvement of the Department of Health Hazard Evaluation and Emergency Response Office (HEER) and the Environmental Protection Agency (EPA) to provide direction of proper removal and disposal of the PCBs.

After discussions with HEER and EPA, specifications needed to be provided for proper removal and disposal of the interior liner of the tank. Additionally, the soils in the drainage ditch needed to be tested for the presences of PCBs, as this is where the tank discharges overflow or washout water. This additional scope necessitated the first amendment to the contract.

Testing from the drainage ditch resulted in the presence of PCBs within the soils. Requirements from EPA require that a PCB soil removal plan must be developed and approved by the EPA and HEER for proper mitigation of the soil in the ditch. Therefore, the second contract amendment was necessary to complete the PCB soil removal plan to satisfy requirements from HEER and EPA.

During the initial stages of construction, the Contractor submitted an RFI requesting that the exterior paint be tested for PCB contamination on the basis that two other DOW tanks have recently tested positive for PCBs in the exterior paint. PCB sampling in the exterior paint is not typically required by the Department of Health or EPA, but the DOW voluntarily chose to sample the exterior coatings of the Paanau Tank No. 1 and Kaua'i Inn Tanks as part of Job No. 18-02, the Island-Wide Tank Rehabilitation of Tanks Project. The positive results from those two tanks led the Contractor to request that the Paua Valley Tank project be tested on the basis that they were built during the same timeframe and may have used similar materials.

DOW staff met with EPA Region IX to request a determination as to whether PCB testing of the exterior paint was required. The EPA representative stated that PCB testing is not a standalone requirement; however, it was clarified that based on case law in California, the EPA can now "reasonably require" the DOW to test the exterior paint for PCBs at the Paua Valley tank because two other tanks in the DOW system tested positive. Therefore, the DOW is now proceeding with testing the tank's exterior paint for PCBs. Should the results indicate that PCBs are present, additional mitigation will be needed for the removal and disposal of the paint and the Contractor will submit a change order for the project.

In the third Amendment the scope of the contract with KAI included the removal of "Additional efforts needed to obtain NPDES Individual Permit" for a contract deduction of \$4,781.12 and the addition of "PCB sampling in the exterior paint" with additional funding in the amount of \$4,779.00. The net difference is a deduction of \$2.12 and therefore no additional funds are needed.

In the fourth Amendment the scope of the contract with KAI includes the preparation of a soil testing plan, soil sampling and testing for PCBs. The additional fee of \$212,719.00 includes contingency tasks that are dependent on the outcome of the initial testing and any additional testing required. If PCBs are not

detected in the initial site testing after the outside tank and roofing material are removed, additional testing will not be needed and the fees for the contingency sampling and testing will not be expended. We have reviewed the proposal from KAI Hawai'i, Inc. for additional services for the work and time extension of 150 days and find it acceptable. Reference Manager's Report No. 21-12.

The Department of Water (DOW) currently has two (2) vacant positions, Waterworks Information Technology Manager (WITM) and Information Technology Specialist (ITS) III, in its Information Technology (IT) Division. Due to the vacancy created with the loss of the Department's WITM, on October 14, 2019, the DOW executed the Second Amendment to Contract No. 666, Review and Update the Department's Information Technology Strategic Plan and IT Project Implementation and Support with Brio Consulting to incorporate Task 1, Support IT Infrastructure. The contract amendment provided the Department with a mechanism for long term support services during periods when one or both of the remaining I.T. employees are on leave.

The DOW has been actively trying to fill the WITM position. During the course of the WITM position recruitment, the ITS III position became vacant and further elevated the necessity to utilize Brio Consulting's IT support services to keep the Department's critical business systems operating. The need for the consultant IT support services are required until the vacant positions are filled as well as during the transition period of recruitment, to operate and maintain the Department's IT systems.

The Seventh Amendment to Contract No. 666 provides services until January 31, 2021 while the IT positions are vacant and recruitment, interview and hiring action from the Department of Human Resources are being complete. The DOW anticipated that to have the WITM position filled in July, however, the selected candidate declined the Department's offer. Re-recruitment of the WITM position is in process and the process for recruitment of the ITS III will follow. It is anticipated that the WITM position hiring action will be complete by January 31, 2021.

Additional funds are requested to continue Task 1, for IT infrastructure support, of this contract until January 31, 2021 to keep business critical systems of the Department in operation. Reference Manager's Report No. 21-07.

CUSTOMER CARE AND BILLING (CC&B) SYSTEM UPDATE:

The DOW has been working with Badger Meters and Beacon to get our system ready for the next phase of our transitions to cellular endpoints within our meter system. We will be in the process of updating our meters, to collect data more accurately and more efficiently. We will also be migrating to a new Beacon software.

We will be starting the testing phase on Tuesday 10/13/20. working with our partners, Badger Meter, Beacon and Prithibi consulting. We will be doing this in a test environment in order to get the bugs out and also to train our employee on the changes being made. We anticipate in accomplishing this within the next month to month and a half.

Candidate interview were held on October 1 & 2, 2020 for the Waterworks Information Technology Manager position. A prospective candidate was selected and the Department has forwarded its recommendations to DHR for review and approval for the position offer.

QUARTERLY *UPDATES* – 3rd **Quarter** (July – September 2020)

WATER QUALITY QUARTERLY REPORT:

- 1. Engineering continues to work with the Lab and contractors to install sample stations in new subdivisions. The new subdivision behind the Po'ipū Shopping Center will also have a sampling station. They will be added to the updated sampling plan required by new Total Coliform Rule. One has been installed in the current Hanamā'ulu project. One more slated for the expansion of the Ulu Ko subdivision. The Lab incorporated the Hanamā'ulu Station into the Routine Sampling Plan in 2020. The Po'ipū Subdivision station is pending. Sampling Points are being looked at to update the site list before end of year when the Compliance Monitoring Data Portal (CMDP) is implemented. Two new sites were added to the RTCR site list. The next sample station may in the new Kulana Subdivision after it is conveyed to DOW.
- 2. Micro data is being submitted to CMDP website. Hawaii is still in the test environment, however, SDWB is saying we are going real time shortly. Covid19 has slowed thing down.
- 3. Continued microbiological sampling of sources to see if any will present problems with fecal indicators. This is part of the Triggered Monitoring part of the Ground Water Rule.
- 4. Phase 2-5 sampling for the 2020-2021 period has begun with System 400 scheduled for 3rd and 4th Quarter 2020.
- 5. Baseline Chemistry for sources ongoing. pH at Wainiha Well is low. The existing soda ash equipment at Wainiha #2 initially boosted the pH to 7.0. We are monitoring it monthly with the addition of alkalinity testing and it seems to be holding. Testing results are sent to SDWB for their records. SDWB has put the system on an advanced monitoring schedule for Lead and Copper (20 samples 2x/year). This is problematic as it is difficult to get volunteers out there because mostly, it is vacation rentals. However, both rounds were accomplished with results below the Action Level so Sys.415 only has to sample once in 2019 which was completed. Sampling also occurred in July of 2020.
- 6. Contract for analytical services with Eurofins has been extended to FY 2020-2021. Contract executed. RTM has been submitted for FY2020 budget. RTM was not submitted for 2021 as contact covers 2021 fiscal year.
- 7. Updated sample site plan and sites on Xcel spreadsheet. Continuing.
- 8. Lab inspection for microbial analysis certification was completed virtually due to Covid 19. Passed, next inspection will be April, 2022.
- 9. Microbiological analysis ongoing with no coliform hits.
- 10. Maintenance and filter replacement completed for RO system. Although we may have to do water suitability testing anyway. Connected autoclave to RO system to use more water. It seems to be working as we are getting conductivity readings below 1.0 uU/cm. Still good.
- 11. UCMR 4 Updating SDWARS inventory and scheduling. Sys. 400 AM1, AM2 and AM3 UCMR4 is completed for 2019. Last UCMR4 sampling will be in October at SWTP.
- 12. PCBs found in Paua Valley tank. Tank has been isolated. Lab is working with SDWB and Engineering to get tank back on line. Ongoing.
 - a. On Kauai entry points to distribution (EPD) are usually after the well head and before the storage tanks. The reason for this is because well water can go into the distribution system before going to a storage tank. This is common to most of DOW sources.
 - b. Therefore, chemical (and to a limited extent, microbiological) samples are taken at the EPDs before going to the storage tanks. DOH does not require sampling from the tanks unless it represents an EPD. There are two tanks that qualify, the Kalaheo Deep Well Tank and the Anahola Tanks.

- c. Because of the recent findings, we are requesting sampling taps on the storage tanks (many do not have them). OPS has installed taps on most of the tanks in question. They have been sampled for PCB.
- 13. sampling and testing with the DOH Lab continues.
- 14. Microbiological QA/QC items for certification completed for 3rd Qtr. 2020.
- 15. Monitoring of chlorides in Sys. 406 ongoing. Waipa Well back in service.
- 16. All Lab personnel are working in Lab. Everyone on 5-8 work schedule.
- 17. Working with Brown and Caldwell on GAC system in Wailua Homesteads. We will be doing the required sampling and paying for the testing.
- 18. Will be looking at the Moalepe Tunnel chlorination project again to revive it.
- 19. The Grove Farm Surface Water Treatment Plant was taken offline for two months while a color issue was being investigated. It is now back on line and the color has cleared.



Executive Summary

The significant changes for this quarter are:

- Represent the Department and participate with neighbor island Managers for statewide water utility coordination and reporting. Recent topics include sharing of information and processes regarding the evolving COVID-19 situation and coordination with DOH for their contingency planning.
- WRP division staff Michael Hinazumi continues to volunteer and in the interim oversee the Information Technology Division.
- The Division prepared proposed rule amendments to address the FRC impact fee to size limited dwellings, Guest Houses containing kitchens and Affordable Rental Units (ARUs). 



BACKGROUND:

Contract NTP Date: July 10, 2017
Original Contract End Date: March 16, 2018

New Contract End Date: Estimate March 21, 2021

The DOW started Job No. 17-10, WP2020 Project No. KW-07 Rehabilitate Paua Valley Tank #1, 0.5MG Concrete to address the aging tank located in Kekaha and to perform repairs,

including fixing a leak located at the base of the tank. As part of the project, DOW performed hazardous material surveys to ensure proper disposal of any material intended to be removed. The presence of polychlorinated biphenyls (PCBs) within the interior of the tank was not expected, based on DOW prior tests for PCBs of the tank water. However, results of the hazardous material survey identified the presence of polychlorinated biphenyls (PCBs) within the interior liner of the tank (testing for PCBs on exterior of tank was not required), which required the shutdown of the tank and the involvement of the Department of Health (DOH) Hazard Evaluation and Emergency Response Office (HEER) and the Environmental Protection Agency (EPA) to provide direction of proper removal and disposal of the PCBs. Design mitigation of PCBs if detected was not included in the scope of work.

First Amendment (executed May 15, 2018)

After discussions with HEER and EPA, specifications needed to be provided for proper removal and disposal of the interior liner of the tank. Additionally, the soils in the drainage ditch needed to be tested for the presences of PCBs, as this is where the tank discharges overflow or washout water.

Second Amendment (executed September 11, 2019):

Testing from the drainage ditch resulted in the presence of PCBs within the soils. Requirements from EPA require that a PCB soil removal plan must be developed and approved by the EPA and HEER for proper mitigation of the soil in the ditch. Therefore, the second contract amendment was necessary to complete the PCB soil removal plan to satisfy requirements from HEER and EPA. EPA clarified that construction of the tank rehabilitation was not dependent on the soil removal plan and mitigation of the soil in the ditch and could proceed independently from the soil mitigation of the ditch. The DOW decided to proceed with the construction of the tank rehabilitation.

Third Amendment (executed June 8, 2020):

During the initial stages of construction, the Construction Contractor submitted an RFI requesting that the exterior paint be tested for PCB contamination on the basis that two other DOW tanks have recently tested positive for PCBs in the exterior paint. PCB sampling in the exterior paint is not typically required by the Department of Health or EPA, but the DOW voluntarily chose to sample the exterior coatings of the Pa'anau Tank No. 1 and Kaua'i Inn Tanks as part of Job No. 18-02, the Island-Wide Tank Rehabilitation of Tanks Project. The positive results from those two tanks led the Construction Contractor to request that the Paua Valley Tank project be tested on the basis that they were built during the same timeframe and may have used similar materials.

DOW staff met with EPA Region IX to request a determination as to whether PCB testing of the exterior paint was required. The EPA representative stated that PCB testing is not a standalone requirement; however, it was clarified by EPA that based on case law in California, the EPA can now "reasonably require" the DOW to test the exterior paint for PCBs at the Paua Valley tank because two other tanks in the DOW system tested positive. Therefore, the DOW proceeded with testing the tank's exterior paint for PCBs. Should the results indicate that PCBs are present, additional mitigation will be needed for the removal and disposal of the paint and the Construction Contractor will submit a change order for the project.

Fourth Amendment (proposed):

The PCB sampling results for the exterior paint and roof coating on the Paua Valley Tank (Reservoir No. 1) were positive for PCB. As a result of this, EPA is requiring testing of the soil

and asphalt paving surrounding the reservoir. Additional environmental and engineering work are required to comply with EPA and DOH requirements. Depending on the test results further testing and mitigation may be required. We have reviewed the proposal from KAI Hawaii, Inc. for additional services required and find it acceptable.

The EPA is requiring that PCB testing of the asphalt and soil around the tank be done after the construction of the exterior tank work is completed. The DOW is considering an option for the DOW to voluntarily complete non-required testing of the first layer of asphalt and soil prior to the start of the construction work on the exterior of the tank to establish a baseline of PCB detected concentrations, if any. If pre-construction testing is done, the testing after the construction of the exterior work on the tank will still be required by EPA. The proposed Fourth Amendment will allow the testing of the first layer of asphalt and soil to be done prior to construction of the exterior of the tank if the DOW choses to do so. If the DOW decides to complete the pre-construction testing, it will require an additional contract amendment and Board approval of additional funds (estimated at \$80,000) to be approved at a future Board meeting to complete the post construction (exterior work) testing that is required by the EPA.

At this time the DOW has not made a determination if the non-required testing prior to the start of construction of the exterior of the tank should be done or not. The DOW staff will provide a recommendation to the Manager for consideration upon completion of the analysis.

Summary of Design:

- **July 10, 2017** Original contract NTP Consultant completed hazardous material testing required in the contract scope of work. Consultant test results report in December 2017 included detection of PCBs in the interior lining of the tank. DOW did not expect this. (note: testing of the tank exterior for PCBs was not required by DOH or EPA at that time and not included in the design scope of work)
- May 15, 2018 1st Amendment to contract executed. Amendment is to address EPA requirement for DOW to mitigate/dispose of interior tank lining and to test soil in drainage ditch (off-site from tank site) for PCBs.
- September 11, 2019 2nd Amendment to contract executed. Amendment is to address PCBs being detected in the soil samples from the drainage ditch and subsequent EPA and DOH HEER requirements to address the PCB detected in the ditch soil. EPA clarified that construction of the Paua Tank can proceed, as it is not contingent on the mitigation of the PCB detected in the drainage ditch soil. DOW decided to proceed with construction and a construction contract was executed.
- **June 8, 2020** 3rd Amendment to contract executed. Amendment is to address Construction Contractor's request to test exterior of tank for PCBs and subsequent EPA determination that the testing of the tank exterior needed to be done. This Amendment is for the consultant to complete the additional testing required by EPA.
- October 22, 2020 Proposed 4th Amendment to contract. Amendment is to address PCBs being detected in the exterior paint and roofing material of the tank and subsequent EPA requirement to test the asphalt paving and soil surrounding the tank for PCBs.
